### DAY ONE: Saturday, July 13, 2024 - SAN FRANCISCO DEPARTURE

2:45pm Arrive at San Francisco International Airport and check in. You will be met by your World Projects Tour

Manager, Gemille Walker, who will travel with you throughout the trip.

After checking in your luggage, move through security and onto your departure gate.

and scheduling – TBC).

Evening Dinner on your own.

Later, load the coaches and return to the hotel in

Bilbao.







## DAY FOUR: Tuesday, July 16, 2024 - BILBAO / LOCATION TBD (B,D) - Performance (Concert Bands)

Morning Breakfast provided at the hotel.

This morning, transfer to location TBD (location will depend on concert venue – possibilities could include Bilbao, Pamplona, Vitoria-Gasteiz, or even Bayonne in nearby France). Enjoy time to explore on

your own.

Afternoon Lunch on your own.

Transfer to tonight's concert location. Group **rehearsals** at tonight's concert

venue (Concert Bands).

Evening Dinner as a group nearby concert venue.

PERFORMANCE (Concert Bands) at location TBD (possibly the Bilbao Teatro Campos Elíseos, Teatro Felix Petite in Vittoria-Gasteiz, Teatro Santander – this concert may also be part of a summer series at an outdoor or indoor public venue such as Museo de Arte Sacro or the San Pedro Plaza in Bilbao, etc.) – this concert may be share

with a local ensemble.

After the concert, return to the hotel in

Bilbao.



# DAY FIVE: Wednesday, July 17, 2024 – BILBAO / SAN SEBASTIÁN (B) – Performance (Concert Bands)

Morning Breakfast provided at the hotel.

After breakfast, load the coaches and transfer to San Sebastián.

Upon arrival, enjoy a guided tour of San Sebastián, highlights to include the City Hall, Kursaal Palace,

the Cathedral, and the Old Port. The tour will also include the funicular to the top of Monte Igueldo for wonderful views of the city and the Atlantic Ocean. After your tour, the rest of the day is free for lunch and exploring on your own. Possible activities could include

(all cost on own):

Enjoy the wonderful city beach

• Kayak or surf on the bay

• Go rollerblading or bicycling along the shore

• Shop in the city center

Hike to the castle

• Visit the aquarium and/or the cathedral

# <u>DAY SIX: Thursday, July 18, 2024 – BILBAO → VALENCIA (B, D)</u> – Performance (Concert Bands)

"City of Valencia" International Wind Band Contest
Morning Breakfast provided at the hotel.

This morning, check-out of the hotel and load the coaches and instrument truck.

Depart for Valencia via Zaragoza (~200 miles / ~3.5-hour drive). Arrive into Zaragoza – once the residence of the kings of Aragon.

Afternoon Enjoy time for lunch on your own and to explore Zaragoza on your own in chaperone groups.

Meet back as a group and load the coaches. Continue on to Valencia (~200 miles / ~3.5-hour drive).

Arrive into Valencia.

Valencia is Spain's third largest city, located within one of Europe's most intensely farmed regions (famous for Valencia oranges and cava grapes). It is noted for its warm coastal climate, exuberant outdoor living and nightlife, and for being the center for trade and manufacturing. Valencia is a city full of contrasts with its medieval core alongside futuristic architecture, traditional paella and new-age restaurants, and both a business culture (with one of the largest ports in Spain) but also a laid-back friendly Mediterranean lifestyle.

Possible Pre-Contest *PERFORMANCE* (Concert Bands) in Valencia as part of the "City of Valencia" International Wind Band Contest (possibly at the Mercado Colón (Columbus Market) or other public location).

Late Afternoon After the concert, transfer to local 3-star hotel and check-in – time to settle into rooms.

**Evening** 

Enjoy a dinner as a group at a local restaurant (possibly paella!).

Attend the "City of Valencia" International Wind

Band Contest Concert.

The event takes registrations for international groups in fall, 2023.

After the concert, return to the hotel.

Founded in 1886, the "City of Valencia" International Wind Band Contest has been a cultural institution in Valencia for over 135 years. Split into 4 divisions (divisions are determined by group size), the event features local Spanish bands as well as international groups. There are concerts spread over 4 days – each division plays in a concert together on one of the days at the stunning Palau de la Música. Each division is restricted to 5-6 bands total – each band performs a required piece, a paso doble of their choosing, and a "free" piece of their choosing. The jury selects a  $1^{st}$ ,  $2^{nd}$  and  $3^{rd}$  place winner in each category and each winner wins a cash prize (£1000+).







### DAY SEVEN: Friday, July 19, 2024 - VALENCIA (B) - Performance (Jazz Band)

"City of Valencia" International Wind Band Contest

Morning Breakfast provided at the hotel.

This morning, enjoy a Guided Walking Tour of Valencia which will take you past such sights as the Cathedral and the Plaza del Ayuntamiento – the largest square in


Valencia.

Afternoon Lunch on own in Valencia (possibly at the Mercat

Central).

Enjoy time to explore Valencia in chaperone groups. Some possibilities include (costs on own):

 Walking along the old Túria river bed, now a park with soccer and rugby fields, an artificial boating lake, athletics track, playgrounds, fountains, and trails



- Wandering the Museo de Bellas Artes home to one of the most outstanding painting archives in Spain, renowned for its collections of primitive Valencian painters, as well as works by El Greco, Velázquez, Murillo and Goya
- Spend the afternoon at one of Valencia's beaches
- Further explore the shops and sights of Old Valencia

Possible **soundcheck** for the jazz band at tonight's venue.

Evening Dinner on own in Valencia.

**PERFORMANCE** (Jazz Band) in Valencia (possibilities could include a jazz club such as Black Note Club, as part of the "Pre-Contest" public performance program of the festival, or as part of the outdoor summer jazz festival or Feria de Julio celebrations).

After the performance, return to the hotel.

## DAY EIGHT: Saturday, July 20, 2024 - VALENCIA (B) - Performance (Concert Bands)

Morning Breakfast as a group at the hotel.

This morning, enjoy a visit to the City of Arts and Sciences including admission the oceanographic aquarium.

The City of Arts and Sciences is Valencia's most visited tourist site. The stunning complex is made up of an aquarium, IMAX theater, planetarium, open-air oceanographic park, performing arts center and more!

Afternoon Lunch on your own at or near the City of Arts and Sciences.

Return to the hotel to get ready for this evening.

Evening Dinner on own.

**PERFORMANCE** (Concert Bands – combined) as part of the "City of Valencia" International Wind Band Contest at the Valencia Palau de la Música (subject to successful application).

NOTE: Should El Cerrito HS Combined Concert Band have less than 80 performers, the performance will be scheduled for July 19 – if this occurs then activities for July 19 will be on July 20 and vice versa.

After the concert, return to the hotel.







## <u>DAY NINE: Sunday, July 21, 2024 – VALENCIA → BARCELONA (B, D) – Performance (Concert & Jazz Bands)</u>

Morning Breakfast provided at the hotel.

This morning, check-out of the hotel and load the coaches and instrument truck.

Depart for Barcelona (~220 miles / ~4-hour drive).

Afternoon Lunch on own in Barcelona.

Transfer to tonight's concert location (possibly in

nearby Girona or Tarragona).

Group rehearsals at tonight's concert venue

(Concert Bands & Jazz Band).

Evening Dinner as a group nearby concert venue.

**PERFORMANCE** (Concert Bands & Jazz Band) at location TBD near Barcelona (possibly the Auditori de Girona, the Auditori Procornella in

Barcelona, or the Palau Tarragona).

After the concert, transfer to the Hotel Fira Congress Barcelona to check-in and retire for the evening.

Afternoon Lunch on your own in Barcelona.

The afternoon is free to explore Barcelona (in chaperone

groups).

Possible activities could include (all costs on own):

- Further explore the shops and sites of the Gothic Quarter
- Take a tour of the stunning Palau de la Musica Catalana
- Explore Gaudi masterpieces in the Eixample district

Late Afternoon Return to the hotel to get ready for tonight's activities.

Possible soundcheck for the jazz band at tonight's venue.

Evening Dinner on own in Barcelona.

**PERFORMANCE** (Jazz Band) in Barcelona for the jazz band (possibilities could include a jazz club such as Jazz Club Jamboree, as part of a summer concert program such as the Poble Espanyol, or as part of a collaboration with a summer series at a school such as Taller de Musics – may be an outdoor performance).

After the performance, return to the hotel.







### DAY ELEVEN: Tuesday, July 23, 2024 – BARCELONA (B) – Performance (Concert Bands)

Morning Breakfast provided at the hotel.

This morning, visit La Sagrada Familia, Gaudi's stunning masterpiece, which was left unfinished at his death in 1926 (TBC – subject to ticket availability).

The remarkable Sagrada Familia displays Gaudi's trademark organic style, and is the symbol of Barcelona's individualism, housing an exhibition of the building's history and the burial place of Gaudí in the church's crypt. The church has been under construction since the 1880s and is scheduled to be finished in 2026.



After your visit, depart for Montjuïc Hill to take in some beautiful sights

over the city.

Afternoon Lunch on your own in Barcelona.

Transfer to tonight's concert location (possibly the Conservatori del Liceu

Auditorium or Sala 2 of the Auditori Oriol Martorell).

Group rehearsals at tonight's concert venue (Concert Bands).

Evening Dinner on own nearby concert venue.

PERFORMANCE (Concert Bands) - this concert may be shared with a

local ensemble.

After the concert, return to the hotel.



Morning Breakfast provided at the hotel.

This morning, enjoy a visit to Parc Güell, one of the largest green spaces in Barcelona and designed

by Antoni Gaudí.

Afternoon Lunch on own in Barcelona.

The day is free to explore Barcelona on own in

assigned groups.

Possible activities could include (all cost on own):

- Visit Barceloneta Beach
- Enjoy one of Barcelona's many museums (Joan Miro, Picasso, Museum of Catalan Art, etc.)
- Shop for last minute souvenirs along La Ramba

Evening Farewell to Spain dinner as a group.

Afterwards, return to the hotel.

- Passport/Visa/ETIAS processing fees (most US Passport holders do not require a visa to travel to Spain for up to a 90 day stay)

- Items of a personal nature (laundry, room service, internet connection, telephone fee, mail, etc.)
- Trip Cancellation, Cancel for Any Reason (CFAR), and Musical Instrument Insurance



# AIR INFORMATION SHEET – INSTRUMENTAL TRAVELING WITH GROUPS BY AIR

- 1. Adult passengers 18 and older must show valid identification at the airport checkpoint in order to travel. Students under age 18 should show a school identification card. All international travelers must have a valid passport.
  - a. Beginning May 7, 2025, if you plan to use your state-issued ID or license to fly within the U.S., make sure it is REAL ID compliant. If you are not sure if your ID complies with REAL ID, check with your state department of motor vehicles.
- 2. Make sure that all luggage is tagged with the owner's name, address, and phone number. It's also recommended that this information is kept inside the luggage as well, in case the outside tag is removed.
- 3. All checked instruments must be packed in hard-shell cases for protection against damage during handling. Insurance is recommended for instruments when traveling by air.
- 4. Check the Transportation Security Administration (TSA) website regarding prohibited items in checked luggage and carry-ons and inform all travelers.
- 5. Inform travelers about the security screening process at the airport. This information is also available on the TSA website. Photo ID and boarding pass are first examined. For passengers not holding a TSA Pre-Check boarding pass, they must remove everything in pockets, remove shoes and coats/outerwear, remove laptops from bags and place them alone in a bin, and remove the quart size plastic bag of 3.4 oz. or less liquids from luggage and place it in a bin. Knowing these points will speed the security screening process.
- 6. Keep baggage claim ticket until baggage has been retrieved. Instrument cases should be opened in the baggage claim area and the instruments checked for damage. If damage is detected, go to the baggage services office for your airline BEFORE leaving the airport. Even if the airline does not assume responsibility for the damage, a written report must be filed in order to process any insurance claim.

Below is a basic guideline to assist you with completing the Air Equipment List. The dimensions and/or weights of your instruments may differ. Please indicate actual dimensions and weights of your instruments on the form.

The following instruments can be carried onto the plane (if in a standard size case) pending space availability: Flutes/Piccolos, Oboes, English Horns, Clarinets, Alto Saxophones, Trumpets, Violins, and Violas.

Those instruments with asterisks (\*) may be carried on or gate checked (at no cost at the gate to be placed under the plane), pending actual dimensions and overhead bin space, and at the discretion of check-in and/or gate agents.

# **Frequently Asked Questions**

Your tour to Spain is just around the corner! We are very pleased to have the opportunity to share this experience with you and your group. Please take the time to read through this helpful FAQ sheet as you begin preparing for your tour! We encourage you to share this document with your travelers as well.

### 1. ARRIVAL:

# a. What happens once I arrive at the airport?

Your World Projects Tour Manager will meet your group at the Iberia Airlines check-in desk at San Francisco International Airport. Please arrive by the time indicated on your itinerary. The Tour Manager will work with Iberia to acquire the group's boarding passes and get everyone checked in as quickly as possible. It is World Projects' recommendation that travelers have their valid passports ready before they approach the desk.

When checking in, it is best if the group lines up and checks in in chaperone groups. It is also recommended that you proceed through security in your chaperone groups. Once the group has arrived at their destination city, baggage claim will be the final meeting point in the airport before departing.

## b. What if my instrument is lost or damaged in-flight?

Upon arrival, after you have collected your luggage, please check instruments to make sure they have arrived safely. If any damage is detected or a piece of luggage is lost, a claim must be filed with the airline **before** leaving the baggage claim area. Your Tour Manager will advise you on getting the instrument repaired or, depending on the severity of the damage, acquiring a rental. Once all of your bags are accounted for, the coaches will arrive at the curb to pick you up. We recommend that you assign 2-3 group travelers to assist in loading luggage and instruments onto the coaches. Note that coach transportation is provided only for paid participants. Anyone traveling on own must make their own arrangements for transportation to and from the airport.

### 2. HOTEL:

# a. How do I get my room key?

Upon arrival at the Hotels each person will be responsible for bringing their own luggage into the hotel. The Group's Tour Manager will pick up keys and hand them out to the group leader. The director will be given a master list of room assignments for the group.

Please note that due to the volume of travelers, all hotel rooms may not be ready upon check in. We thank you on behalf of the hotel for your patience.

# b. What is the hotel like?

All amenities (such as room service, pay TV, etc) will be turned off for the duration of your stay. Staff or chaperones that would like these amenities must present a credit card to the front desk for charges. World Projects will not accept any room charges made during your stay. Information about WiFi will be discussed closer to your departure.



Quiet hours are typically from 10:00pm until 7:00am – please have students refrain from rehearsing in rooms or any common areas of the hotel. Hotel security will notify directors if excessive noise or horseplay is reported.

#### c. Is WiFi available at the hotel?

All hotels will have free WiFi in the hotel lobbies and guest rooms.

### d. What are the elevators like at the hotel?

There are a limited number of elevators available. After check-in, it will take some time to get everyone in an elevator and up to their guest rooms. When gathering for group movements and activities, we recommend planning in extra time in case there is heavy elevator traffic.

#### 3. PERFORMANCES:

# a. What to bring and what to wear for outdoor performances?

Please assemble in the hotel lobby at your designated time. Your performance attire is up to your directors' discretion. We will have clothespins to help secure music to stands (no windscreens). We recommend bringing water and sunscreen, as performance spaces may not be shaded or sheltered. Please note that there is no security provided for instrument cases/belongings while performing. World Projects recommends assigning several chaperones to monitor the group's belongings should you feel uncomfortable leaving belongings unattended.

### b. What happens if it rains?

There is no indoor or alternate venue planned for inclement weather. In the event of light rain, the director may choose whether or not to perform. In the event of severe weather, the concert will be cancelled.

## c. What do I wear during a sound check?

Depending on the proximity to performance, you may need to wear your performance attire for soundchecks. More information will be sent out to the group leader closer to the tour.

### 4. **GENERAL**:

### a. Is the tour all inclusive?

A detailed list of the inclusions and exclusions can be found on your tour itinerary that you will receive from your director.

# b. What is the cancellation policy?

The payment schedule at the bottom of your costing page provides a detailed description of our cancellation policy.

### c. Does World Projects provide insurance for the tour?

All members of US-based groups (within the 50 states) traveling with World Projects are covered by a post-departure travel protection policy through TripAssure. The policy provides emergency medical, trip delay, 24-hour assistance, and other valuable coverage while on tour. This policy does not include trip cancellation insurance. If you wish to purchase "Trip Cancellation" or CFAR (Cancel for Any Reason Insurance) to protect your investment further, you may do so on



your own at an additional cost. World Projects and its employees are not insurance agents, providers, or experts, so we advise everyone to reach out to their trusted provider for further information.

d. What happens if someone gets sick or tests positive for COVID during the festival? In the event that someone traveling falls ill, World Projects will be available to assist with logistics in seeing through your group's contingency policies. World Projects does not offer covid testing or have a nurse on sight. World Projects does not have empty hotel rooms on hold for quarantining unless previously requested during the planning process. Should a quarantine hotel room, transportation to a medical facility, covid test, alternative transportation, etc. be deemed necessary, World Projects festival staff members will work with the group leaders to assist. Any associated costs will be the responsibility of the group at the time of use.

## e. What if I forget something on a bus or at a restaurant?

A chaperone should be designated to check the buses after each coaching transfer to make sure that nothing is left behind. If something is left behind, please notify your Tour Manager as soon as you realize an item is lost. Once lost, cell phones, jackets, cameras, etc. are extremely difficult to retrieve. We will do our best to contact the coach company or restaurant to report the loss. Should the item be located, we will alert the group where they need to send a representative to pick up the item.

## f. How do I pack my instrument for the plane?

Depending on its size and weight, you may be required to check your instrument. Please consult with your director about instruments that qualify as checked baggage so you may properly prepare your instrument to travel in the cargo bay under the plane. Instruments being checked must travel in a hard-shell case. Even if you are not checking your instrument, take special care in protecting it from the changes in environment during flight. Strings should be loosened while in flight as wood can expand and compress with the changes of pressure. For wind instruments, ensure all moisture is absent from the instrument before arriving at the airport. Please remove mouthpieces and reeds from cases and travel with them in carry-on bags. Please do not lock cases or carry on any tools for making reeds as they may be confiscated by TSA.

g. What if I want to go on the tour, but I want to travel to our destination before the trip's start date, or return after the return date?

Air deviations may be an option for travelers who want to extend their trip. Air deviations depend on airline policies. If you wish to choose this option you can speak to your World Projects Production Manager about your choices. **Please note:** those whose air schedule does not match the group will be responsible for acquiring their own transportation and accommodations during the dates that they are not traveling with the group.
